If you do wear a suit and tie, opt for solid neutral colors that complement each other.

Skirts should be at least knee-length or below the knee, and jackets should be a close but comfortable fitting. Try to avoid multi-color patterns, mismatched clothing, shoes that are falling apart, and overly revealing attire. If you choose to wear make-up, consider lighter colors instead of bold lipsticks or overpowering eyeshadow shades.

 General Grooming And Accessories - Pay attention to detail, make sure your fingernails are clean, your hair is neatly styled, and you have exercised basic hygiene, such as cleaning your teeth and bathing before dressing for court. People do notice things such as unpleasant odors, chipped nail polish, or greasy-looking unkempt hair.

Keep accessories to a minimum, especially if you are in court over a financial hardship situation. Wearing flashy jewelry may give others the wrong impression. Simple accessories such as your everyday watch or a plain-colored bracelet are suitable enough. If you

wear glasses, make sure they are clean and free from dust, fingerprints, and dirt.

• Make The Right Impression - The court needs to see the very best of you, so clothing items such as ripped t-shirts or jeans, mini skirts, sportswear, or anything containing offensive logos are not seen as appropriate for a courtroom. Dirty or stained clothing, overpowering fragrances, flip-flops, and sunglasses (unless medically required) are not recommended for attending a court date.

Allow plenty of time to prepare for your court appearance. Make sure you have enough time to get ready and arrive early at the court. If needed, find out where the court is and where you need to go before the day of your court date. Have all the documents you are going to need for court and double-check that you have everything before you leave home.
